With children and young people relying on their tech at home for learning and entertainment during lockdown, it remains vital to keep conversations about online safety going and raise awareness of reporting routes if something goes wrong.

Here's a summary of the Thinkuknow resources available to you to deliver remote learning, education in your setting, and help parents and carers to support their child at home.

Online safety at home packs

Embed the ClickCEOP button in your website

The ClickCEOP button provides children aged 10+ with a direct route to report online sexual abuse if they feel they do not have a trusted adult to go to. Just email ceopeducation@nca.gov.uk with your website URL to get access to the button and guidance on how to use it.

Help CEOP learn more about young people and the dark web

CEOP are currently working with The Children's Society and Marie Collins Foundation to find out more about young people's experiences using the dark web, and how they can be protected from encountering the associated risks.

To learn more about the extent of young people's experiences using the dark web, they want to hear from all professionals working with 11 to 18 year olds. This includes those without prior knowledge or experiences of young people using the dark web. The survey should take roughly 10 minutes to complete and will close on Friday 22 January.
