

# Safeguarding offer to schools 2023-2024

### Options for schools:

#### Safeguarding reviews;

- Brief: half a day- key headlines SCR, pupil voice, website, policy, DSL discussion
- **Detailed:** full day or more, depending on school size.

## Safeguarding Spotlight Package -1 Grow School Improvement Package Day

#### The 2023-2024 Package includes:

A suite of 4 certified recorded Spotlight CPD sessions for all school staff, and 2 sessions for parents. The sessions are each an hour long, are delivered remotely and can be joined at a time to suit staff teams and/or individuals. They are available for the whole term in which they run.

4 Spotlights - whole staff community (1 hour):

- Online Safety
- Child on Child
- Radicalisation
- Staff Professional Behaviour (including code of conduct, low-level concerns and whistleblowing)

2 Spotlights - parents/carers (1 hour):
